Q23 Part C. Comments regarding possible challenges in meeting the objectives of the Convention (Art. 21, para. 1)

Se identifica la necesidad de que el Convenio desarrolle los mecanismos necesarios para optimizar el procedimiento de consentimiento por escrito para la importación de mercurio a fin de que se pueda: (1) conocer con certeza el movimiento transfronterizo del mercurio, no solamente desde el punto de partida y llegada sino también, de ser el caso, los puntos de tránsito y reexportación del mismo (como es el caso de las zonas francas o de libre comercio); (2) identificar claramente los usos destinados del mercurio objeto del comercio, contando inclusive con la información necesaria para verificar su fuente de origen; y, (3) tener plazos para recibir respuesta de otra Parte. 

Además, a fin de alcanzar los objetivos del Convenio, se identifica la necesidad de: (1) fortalecer las capacidades del personal a cargo del control en frontera del mercurio y desarrollar protocolos para la identificación, el decomiso, transporte, manejo, etiquetado y almacenamiento de mercurio; considerando que el control del comercio ilegal de mercurio representa uno de los principales obstáculos para lograr la reducción y eliminación del mismo; (2) fortalecer las capacidades nacionales para el desarrollo de instalaciones para el almacenamiento provisional de mercurio; considerando que las altas tasas de decomisos de mercurio por actividades ilícitas generan que este químico tóxico se almacene temporalmente en lugares inadecuados (ej. oficinas) ocasionando riesgos a los operarios; y, (3) adoptar mecanismos para incentivar el desarrollo de tecnología para la estabilización y disposición final de mercurio; puesto que a la fecha no se cuenta en el Perú con alguna instalación para la eliminación definitiva de desechos mercurio quedando como única opción la exportación de los mismos para su eliminación.
